

Welcome Bonus Promotion

Promotion Details

New clients who open a new account with MYFX Markets are eligible for a 50% welcome bonus on their first deposit, up to \$400.

Bonus Expiry Conditions

Withdrawal/Transfer: If a withdrawal or fund transfer is made from the account that received the bonus.

Expiry: If the bonus expires.

Fraud: If actions violating our specified rules for fraudulent transactions are detected.

General Terms & Conditions

- **Reflection Time:** Bonuses are reflected on deposits within 1-2 business days.
- **Exclusions:** Corporate accounts, MAM/PAMM accounts, Micro accounts, **Incubation Accounts**, or Copy Trading accounts are NOT eligible for this promotion. Residents of the following countries are not eligible for this campaign.
